Regulations:

1. All entrants must have worked on the entry
2. A fabric square with your name, and title of quilt must be attached to the bottom right corner (when facing back) of each entry
3. All quilts must have a four inch sleeve on the top if they are to be hung in the show
4. All entries accepted at the discretion of the convener - if in doubt please call
5. One entry form must be completed for each entry submitted - NO LATE ENTRIES ACCEPTED

- Q-1-1 LARGE BED QUILT - Complete quilt, top and quilting done by one person. Any technique and any type of quilting. Perimeter greater than 310"**
- Q-1-2 LARGE BED QUILT - Group quilt. More than one person has worked on the quilt. Any technique and type of quilting. Perimeter greater than 310"**
- Q-1-3 SMALL BED QUILT AND CUDDLE QUILTS - Maximum Perimeter 310"**
- Q-1-4 TRADITIONAL WALL QUILT - based on patterns or traditional quilt blocks.**
- Q-1-5 ORIGINAL DESIGN REPRESENTATIONAL WALL QUILT - depicts landscapes, portraits and pictures that are realistic. Any technique.**
- Q-1-6 ORIGINAL DESIGN ABSTRACT WALL QUILTS - Explores shapes, textures, colour, embellishments, etc.**
- Q-1-7 WEARABLE - Must be quilted**
- Q-1-8 CHALLENGE - Theme: "Canada 150 & Growing" - can be up to 48" square, open to any quilt technique Entry must reflect the theme and have been made in the 12 months preceding the 2017 show**
- Q-1-9 OTHER - Any quilted item that does not fit in the other categories.**
- Q-1-10 FOR DISPLAY ONLY - All quilt show items that will NOT be judged.**
